Abstract

We consider the problem of mean-variance optimal execution in a market with limited liquidity. We assume a very general price impact function that captures all possible price impacts - whether it be *instantaneous*, *temporary* or *permanent*. Our main contribution is the derivation of closed-form expressions for the optimal strategies.
